6	A BILL to amend and reenact §§ 19.2-11.8 and 19.2-11.11 of the Code of Virginia, relating to physical
7	evidence recovery kits; victim's right to notification; storage.

8	Be it enacted by the General Assembly of Virginia:
9	1. That §§ 19.2-11.8 and 19.2-11.11 of the Code of Virginia are amended and reenacted as follows:
10	§ 19.2-11.8. Submission of physical evidence recovery kits to the Department.
11	A. A law-enforcement agency that receives a physical evidence recovery kit shall submit the
12	physical evidence recovery kit to the Department for analysis within 60 days of receipt, except under the
13	following circumstances: (i) it is an anonymous physical evidence recovery kit that shall be forwarded to
14	the Division for storage; (ii) the physical evidence recovery kit was collected by the Office of the Chief
15	Medical Examiner as part of a routine death investigation, and the medical examiner and the law-
16	enforcement agency agree that analysis is not warranted; (iii) the physical evidence recovery kit is
17	connected to an offense that occurred outside of the Commonwealth; (iv) the physical evidence recovery
18	kit was determined by the law-enforcement agency not to be connected to a criminal offense; or (v) another
19	law-enforcement agency has taken over responsibility for the investigation related to the physical evidence
20	recovery kit. When a state or local law-enforcement agency located within the Commonwealth has taken
21	over responsibility for the investigation related to the physical evidence recovery kit as provided in clause
22	(v), unless one of the exceptions in clause (i) through (iv) also applies, the physical evidence recovery kit
23	shall be transferred to such law-enforcement agency and such law-enforcement agency shall submit the
24	physical recovery kit to the Department within 60 days of receipt from the original receiving law-
25	enforcement agency.

26 B. Upon completion of analysis, the Department shall return the physical evidence recovery kit to 27 the submitting law-enforcement agency. Upon receipt of the physical evidence recovery kit from the 28 Department, the law-enforcement agency shall store the physical evidence recovery kit for a period of 10 29 vears or until 10 years after the victim reaches the age of majority if the victim was a minor at the time of 30 collection, whichever is longer. The law-enforcement agency shall store the physical evidence recovery 31 kit for a period of 10 years following the receipt of a written objection to the destruction of the kit from 32 the victim. After the mandatory retention period or any additional 10-year storage period has lapsed, the 33 law-enforcement agency shall, unless the victim has made a written request not to be contacted for this 34 purpose, make a reasonable effort to notify the victim of the intended destruction of the physical evidence 35 recovery kit no less than 60 days prior to the intended date of such destruction. In the absence of a response 36 from the victim, or with the consent of the victim, the law-enforcement agency may destroy the physical 37 evidence recovery kit or, in its discretion, may elect to retain the physical evidence recovery kit for a 38 longer period of time. 39 C. For physical evidence recovery kits that meet the exceptions in clause (ii) or (iv) of subsection

40 A or that meet the exception in clause (iii) and (v) of subsection A that are not transferred to the law-41 enforcement agency outside of the Commonwealth in which the offense occurred or to the law-42 enforcement agency that has taken over responsibility for the investigation related to the physical evidence 43 recovery kit, the law-enforcement agency that received the physical evidence recovery kit shall store such 44 kit for a period of 10 years or until 10 years after the victim reaches the age of majority if the victim was 45 a minor at the time of collection, whichever is longer. After the mandatory retention period, the law-46 enforcement agency may destroy the physical evidence recovery kit or, in its discretion, may elect to retain 47 the physical evidence recovery kit for a longer period of time.

48 <u>D.</u> The DNA profiles developed from physical evidence recovery kits submitted to the Department
49 for analysis pursuant to this section shall be uploaded into any local, state, or national DNA data bank
50 only if eligible as determined by Department procedures and in accordance with state and federal law.

52 A. In addition to the rights provided under Chapter 1.1 (§ 19.2-11.01 et seq.), a victim of sexual 53 assault, a parent or guardian of a victim of a sexual assault who was a minor at the time of the offense, or 54 the next of kin of a deceased victim of sexual assault shall have the right to request and receive information 55 from the law-enforcement agency regarding (i) the submission of any physical evidence recovery kit for 56 forensic analysis that was collected from the victim during the investigation of the offense; (ii) the status 57 of any analysis being performed on any evidence that was collected during the investigation of the offense; 58 (iii) the results of any analysis; and (iv) the time frame for how long the kit will be held in storage and the 59 victim's rights regarding such storage, unless disclosing this information would interfere with the 60 investigation or prosecution of the offense, in which case the victim, parent, guardian, or next of kin shall 61 be informed of the estimated date on which the information may be disclosed, if known. The law-62 enforcement agency shall inform the victim, parent, guardian, or next of kin of the unique identification 63 number assigned to the physical evidence recovery kit utilized by the health care provider and the personal 64 identification number required to view the status of the physical evidence recovery kit and shall provide 65 information regarding the Physical Evidence Recovery Kit Tracking System, unless disclosing this 66 information would interfere with the investigation or prosecution of the offense, in which case the victim, parent, guardian, or next of kin shall be informed of the estimated date on which the information may be **67** 68 disclosed, if known.

69 B. In the case of a physical evidence recovery kit that was received by a law-enforcement agency 70 prior to July 1, 2016, and that has subsequently been submitted for analysis, the victim, a parent or 71 guardian of a minor victim, or the next of kin of a deceased victim shall be notified by the law-enforcement 72 agency of the completion of the analysis and shall, upon request, receive information from the law-73 enforcement agency regarding the results of any analysis, unless disclosing this information would 74 interfere with the investigation or prosecution of the offense, in which case the victim, parent, guardian, 75 or next of kin shall be informed of the estimated date on which the information may be disclosed, if known. 76 A good faith attempt to locate the victim, a parent or guardian of a minor victim, or the next of kin of a 77 deceased victim shall be made if a current address for the victim, a parent or guardian of a minor victim, 78 or the next of kin of a deceased victim is unavailable.

- C. The victim, parent, guardian, or next of kin who requests to be notified under subsection A shall
  provide a current address and telephone number to the attorney for the Commonwealth and to the lawenforcement agency that is investigating the offense and keep such information updated.
- 82 The victim, parent, guardian, or next of kin who requests to be notified under subsection B may
  83 provide a current address and telephone number to the attorney for the Commonwealth and to the law84 enforcement agency that is investigating the offense and keep such information updated.
- B. Nothing contained in this section shall require a law-enforcement agency to disclose any
  information regarding the results of any analysis to a parent or guardian of a minor victim or to the next
  of kin of a deceased victim if such parent, guardian, or next of kin is the alleged perpetrator of the offense.
