

1 HOUSE BILL NO. 191
 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE
 3 (Proposed by the House Committee on Appropriations
 4 on _____)
 5 (Patron Prior to Substitute--Delegate Hodges)

6 A BILL to amend the Code of Virginia by adding in Title 2.2 a chapter numbered 4.5, consisting of a
 7 section numbered 2.2-450, and by adding a section numbered § 2.2-2240.7, relating to health
 8 workforce development; Special Advisor to the Governor for Health Workforce Development;
 9 Virginia Health Workforce Development Fund.

10 **Be it enacted by the General Assembly of Virginia:**

11 **1. That the Code of Virginia is amended by adding in Title 2.2 a chapter numbered 4.5, consisting**
 12 **of a section numbered 2.2-450, and by adding a section numbered § 2.2-2240.7 as follows:**

13 CHAPTER 4.5.

14 SPECIAL ADVISOR FOR HEALTH WORKFORCE DEVELOPMENT.

15 **§ 2.2-450. Special Advisor to the Governor for Health Workforce Development.**

16 The position of Special Advisor to the Governor for Health Workforce Development (the Special
 17 Advisor) is hereby created. The Special Advisor shall be appointed by the Governor and shall be
 18 responsible for coordinating and aligning efforts in collaboration with the Secretaries of Commerce and
 19 Trade, Health and Human Resources, and Labor to (i) expand the health workforce in the Commonwealth
 20 by supporting the coordination of education, training, recruitment, and incentive programs designed to
 21 improve staff retention and build Virginia's health workforce; (ii) address regulatory, payment, and other
 22 issues that negatively impact recruitment and retention of health workers in critical practice areas,
 23 including behavioral health, developmental services, nursing, and public health; (iii) develop a strategy to
 24 address the behavioral health safety net workforce shortage in the Commonwealth; and (iv) oversee the
 25 Virginia Health Workforce Development Fund established by § 2.2-2240.7. The Special Advisor shall be

26 a part of the Commerce and Trade Secretariat and shall support the objectives and programs of the
27 Secretariats of Commerce and Trade, Health and Human Resources, and Labor.

28 **§ 2.2-2240.7. Virginia Health Workforce Development Fund.**

29 A. There is hereby created in the state treasury a special nonreverting fund to be known as the
30 Virginia Health Workforce Development Fund, referred to in this section as "the Fund." The Fund shall
31 be established on the books of the Comptroller. All funds appropriated for such purpose and any gifts,
32 donations, grants, bequests, and other funds received on its behalf shall be paid into the state treasury and
33 credited to the Fund. Interest earned on moneys in the Fund shall remain in the Fund and be credited to it.
34 Any moneys remaining in the Fund, including interest thereon, at the end of each fiscal year shall not
35 revert to the general fund but shall remain in the Fund. Moneys in the Fund shall be used solely for the
36 purposes of (i) providing incentives for the removal of barriers to educating and training health workforce
37 professionals that include increasing eligible faculty, clinical placements, and residencies; (ii)
38 incentivizing the production of health workforce credentials, degrees, and licensures based on a rigorous
39 analysis of the need by the Office of Education and Labor Market Alignment; (iii) addressing regulatory
40 barriers to entering into and staying in health professions; and (iv) providing education and training for
41 health and health science professionals to align education and training initiatives with existing and
42 evolving health workforce needs. Expenditures and disbursements from the Fund shall be made by the
43 State Treasurer on warrants issued by the Comptroller upon written request signed by the Chief Executive
44 Officer or his designee. For purposes of this section, "health workforce" shall include workers in the field
45 of behavioral health.

46 B. The Authority shall establish a process for the issuance of grants to regional health and health
47 science workforce development initiatives established to meet regional health and health science
48 workforce needs by developing and supporting targeted initiatives to address unique regional needs related
49 to health and health science workforce education, training, recruitment, and retention and fulfill the
50 purposes enumerated in subsection A.

51 **2. That the provisions of this act shall expire on July 1, 2026.**

52 **3. That the Special Advisor to the Governor for Health Workforce Development established by this**
53 **act shall, in addition to any other powers and duties, review and evaluate the structure and**
54 **organization of the Virginia Health Workforce Development Authority established by § 32.1-122.7**
55 **of the Code of Virginia and make recommendations to the Governor and General Assembly on the**
56 **long-term administrative structure and funding of the Virginia Health Workforce Development**
57 **Authority on or before November 1, 2022.**
