228	17. Owned and used for personal or official purposes by accredited consular or diplomatic officers
229	of foreign governments, their employees or agents, and members of their families, if such persons are
230	nationals of the state by which they are appointed and are not citizens of the United States;
231	18. A self-contained mobile computerized axial tomography scanner sold to, rented or used by a
232	nonprofit hospital or a cooperative hospital service organization as described in § 501(e) of the United

- 233 States Internal Revenue Code;
- 234 19. A motor vehicle having seats for more than seven passengers and sold to a restricted common235 carrier or common carrier of passengers;
- 236 20. Beginning July 1, 1989, a self-contained mobile unit designed exclusively for human237 diagnostic or therapeutic service, sold to, rented to, or used by a nonprofit hospital, or a cooperative

hospital service organization as described in § 501(e) of the United States Internal Revenue Code, or a
nonprofit corporation as defined in § 501(c)(3) of the Internal Revenue Code, established for research in,
diagnosis of, or therapy for human ailments;

241 21. Transferred, as a gift or through a sale to an organization exempt from taxation under §
242 501(c)(3) of the Internal Revenue Code, provided the motor vehicle is not titled and tagged for use by
243 such organization;

244 22. A motor vehicle sold to an organization which is exempt from taxation under § 501(c)(3) of
245 the Internal Revenue Code and which is organized for the primary purpose of distributing food, clothing,
246 medicines, and other necessities of life to, and providing shelter for, needy persons in the United States
247 and throughout the world;

248 23. Transferred to the trustees of a revocable inter vivos trust, when the individual titleholder of a
249 Virginia titled motor vehicle and the beneficiaries of the trust are the same persons, regardless of whether
250 other beneficiaries of the trust may also be named in the trust instrument, when no consideration has
251 passed between the titleholder and the beneficiaries; and transferred to the original titleholder from the
252 trustees holding title to the motor vehicle;

253 24. Transferred to trustees of a revocable inter vivos trust, when the owners of the vehicle and the
254 beneficiaries of the trust are the same persons, regardless of whether other beneficiaries may also be named
255 in the trust instrument, or transferred by trustees of such a trust to beneficiaries of the trust following the
256 death of the grantor, when no consideration has passed between the grantor and the beneficiaries in either
257 case;

25. Sold by a vehicle's lessor to its lessee upon the expiration of the term of the vehicle's lease, if the lessee is a natural person and this natural person has paid the tax levied pursuant to this chapter with respect to the vehicle when he leased it from the lessor, and if the lessee presents an original copy of the lease upon request of the Department of Motor Vehicles or other evidence that the sales tax has been paid to the Commonwealth by the lessee purchasing the vehicle;

263 26. Titled in the name of a deceased person and transferred to the spouse or heir, or under the will,264 of such deceased person;

27. An all-terrain vehicle, moped, or off-road motorcycle, as those terms are defined in § 46.2-266 100. that: 267 a. Is being titled for the first time in the Commonwealth and that the applicant (i) has owned for 268 more than 12 months or (ii) has owned for less than 12 months and provides evidence of tax paid pursuant 269 to Chapter 6 (§ 58.1-600 et seq.); or 270 b. Would otherwise be eligible for an agricultural exemption, as provided in § 58.1-609.2; 271 28. A motor vehicle that is sold to an organization that is exempt from taxation under 501(c)(3) 272 of the Internal Revenue Code and that is primarily used by the organization to transport to markets for 273 sale produce that is (i) produced by local farmers and (ii) sold by such farmers to the organization; or 274 29. Transferred from the purchaser of the vehicle back to the seller of the vehicle who (i) accepted 275 the vehicle pursuant to the Virginia Motor Vehicle Warranty Enforcement Act (§ 59.1-207.9 et seq.) or 276 (ii) otherwise agreed to accept the return of the vehicle due to a mechanical defect or failure and refunded 277 to the purchaser the purchase price of the vehicle. Classification of farm animals, certain grains, agricultural products, farm 283 machinery, farm implements and equipment; governing body may exempt. 284 A. Farm animals, grains and other feeds used for the nurture of farm animals, agricultural products 285 as defined in § 3.2-6400, farm machinery and farm implements are hereby defined as separate items of 286 taxation and classified as follows: 287 1. **292** 6. Grains and other feeds used for the nurture of farm animals.

8. Farm machinery other than the farm machinery described in subdivision 10, and farm
implements, which shall include (i) equipment and machinery used by farm wineries as defined in § 4.1100 in the production of wine; (ii) equipment and machinery used by a nursery as defined in § 3.2-3800
for the production of horticultural products; and (iii) any farm tractor as defined in § 46.2-100, regardless
of whether such farm tractor is used exclusively for agricultural purposes.

300 9. Equipment used by farmers or farm cooperatives qualifying under § 521 of the Internal Revenue
301 Code to manufacture industrial ethanol, provided that the materials from which the ethanol is derived
302 consist primarily of farm products.

303 10. Farm machinery designed solely for the planting, production or harvesting of a single product304 or commodity.

305 11. Privately owned trailers as defined in § 46.2-100 that are primarily used by farmers in their
 306 farming operations for the transportation of farm animals or other farm products as enumerated in
 307 subdivisions 1 through 7.

308 12. Motor vehicles that are used primarily for agricultural purposes, for which the owner is not
309 required to obtain a registration certificate, license plate, and decal or pay a registration fee pursuant to §
310 46.2-665, 46.2-666, or 46.2-670, or pickup or panel trucks or sport utility vehicles for which the owner is
311 required to obtain a permanent farm use placard pursuant to § 46.2-684.2.

312 13. Trucks or tractor trucks as defined in § 46.2-100, that are primarily used by farmers in their
313 farming operations for the transportation of farm animals or other farm products as enumerated in
314 subdivisions 1 through 7 or for the transport of farm-related machinery.

315 14. Farm machinery and farm implements, other than the farm machinery and farm implements
316 described in subdivisions 8 and 10, which shall include equipment and machinery used for forest
317 harvesting and silvicultural activities.

318 B. The governing body of any county, city or town may, by ordinance duly adopted, exempt in 319 whole or in part from taxation, or provide a different rate of tax upon, all or any of the above classes of 320 farm animals, grains and feeds used for the nurture of farm animals, farm vehicles, and farm machinery, 321 implements or equipment set forth in subsection A. 322 C. Grain; tobacco; wine produced by farm wineries as defined in § 4.1-100; and other agricultural 323 products, as defined in § 3.2-6400, shall be exempt from taxation under this chapter while in the hands of 324 a producer. 325 2. That the second enactment of Chapter 51 and the second enactment of Chapter 52 of the Acts of 326 Assembly of 2022 are amended and reenacted as follows: 327 2. That the provisions of this act requiring the owner or lessee of a farm vehicle claiming an 328 exemption for a farm vehicle provided pursuant to § 46.2-665, 46.2-666, 46.2-670, 46.2-672, or 46.2-329 673 of the Code of Virginia, as amended by this act, to obtain a farm use placard from the 330 Department of Motor Vehicles and to display such placard on the vehicle at all times shall become 331 effective on July 1, 2023 2024.
