 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE
 3 (Proposed by the House Committee on Appropriations

 5 (Patron Prior to Substitute--Delegate Rasoul)

6 A BILL to amend and reenact § 22.1-199.7 of the Code of Virginia, relating to public education;
 7 community schools; Office of Community Schools at Department of Education; Community
 8 School Development and Implementation Planning Grant; state goal.

9 **Be it enacted by the General Assembly of Virginia:**

10 **1. That § 22.1-199.7 of the Code of Virginia is amended and reenacted as follows:**

11 **§ 22.1-199.7. Community schools; interagency task force; Office of Community Schools at**
 12 **the Department; Community School Development and Implementation Planning Grant; state goal.**

13 A. As used in this section:

14 "Identified student" and "identified student percentage" have the same meanings as provided in §
 15 22.1-207.4:1.

16 "Office" means the Office of Community Schools.

17 B. In order to remove nonacademic barriers to learning as a means to enhance student academic
 18 success in public elementary and secondary schools throughout the Commonwealth, the Department of
 19 ~~Education~~ shall establish an interagency task force composed of state and local agencies and entities in
 20 the areas of early childhood development, health, social services, community engagement, family
 21 engagement, higher education, communities in schools, and workforce development for the purpose of (i)
 22 developing a program for the establishment of community schools whereby public elementary and
 23 secondary schools serve as centers for the provision of such community programs and services to students
 24 and their families as may be necessary on the basis of unique needs of the student population to be served
 25 and (ii) developing and providing to the Governor, the Secretary of Education, local school boards, and
 26 other interested state, local, and private entities policy recommendations relating to the coordinated

27 delivery of community services to students and their families and the operation of community schools
28 throughout the Commonwealth in accordance with the Virginia Community School Framework.

29 ~~B.~~C. The community schools program established pursuant to subsection ~~A.~~ B. shall include a
30 process by which school boards and community partnerships consisting of school boards and other
31 community and service providers may apply to the Department ~~of Education~~ to designate an elementary
32 or secondary school in the local school division as a community school. The application process shall
33 include requirements for applicants to provide a plan for the sustainability of the community school and
34 for the measurement of the success and effectiveness of the community school. The Department ~~of~~
35 ~~Education~~ shall consult with the interagency task force established pursuant to subsection ~~A.~~ B. in the
36 selection of applications and the designation of community schools.

37 D. The Department shall establish the Office of Community Schools as an office within the
38 Department for the purpose of supporting the development and growth of community schools throughout
39 the Commonwealth in accordance with the Virginia Community School Framework by collaborating with
40 the interagency task force established pursuant to subsection B; administering state funds provided to
41 school divisions to develop and sustain community school models; assisting school leaders in the
42 application for federal grant funds for their community school models; and providing technical assistance
43 to school personnel and contracted coordinators regarding effective practices and models for community
44 schools and capital considerations relating to community schools, including site acquisition and building
45 construction, renovations, and additions.

46 E. The Office shall establish and administer the Community School Development and
47 Implementation Planning Grant for the purpose of providing grants to school boards that (i) seek to
48 designate any school within the local school division as a community school and (ii) present a plan for the
49 sustainable funding for such community school as part of the grant application to assist with the planning
50 and implementation of such designation over a period of three to five years. In administering and awarding
51 such funding pursuant to such planning grant, the Office shall offer such funding to applicants for any
52 public elementary or secondary school that is in the top 20 percent of public elementary or secondary

53 schools in the Commonwealth for highest identified student percentage based on data from the
54 immediately preceding school year.

55 F. In recognition of the ability of community schools to properly meet the full spectrum of
56 identified student needs in certain communities, it is the goal of the Commonwealth to prioritize funding
57 for the initiatives and grants established in this section to enable their expansion to serve the top 33 percent
58 of public elementary and secondary schools in the Commonwealth for highest identified student
59 percentage based on data from the immediately preceding school year.
