2	AMENDMENT IN THE NATURE OF A SUBSTITUTE

6	A BILL to amend the Code of Virginia by adding a section numbered 56-585.1:14, relating to Phase I
7	Utility; recovery of development costs associated with small modular nuclear facility.
8	Be it enacted by the General Assembly of Virginia:
9	1. That the Code of Virginia is amended by adding a section numbered 56-585.1:14 as follows:
10	§ 56-585.1:14. Recovery of development costs associated with small modular nuclear facility.
11	A. As used in this section:
12	"Phase I Utility" means an investor-owned incumbent electric utility that was, as of July 1, 1999,
13	not bound by a rate case settlement adopted by the Commission that extended its application beyond
14	January 1, 2002.
15	"Project development costs" means all capital and operation and maintenance costs associated with
16	a potential small modular nuclear facility incurred by a Phase I Utility before issuance of a certificate for
17	a small modular nuclear facility located in the Commonwealth, including the costs of evaluation, design,
18	engineering, environmental analysis and permitting, land option, and early site permitting, as that term is
19	defined in 10 C.F.R. § 52.1. "Project development costs" does not include the costs to obtain construction
20	permits, combined licensing costs required by the Nuclear Regulatory Commission, or construction costs
21	other than construction costs necessary for early site permitting.
22	"Small modular nuclear facility" means a nuclear reactor that has a rated electric generating
23	capacity of not more than 500 megawatts that is capable of being constructed and operated either alone or
24	in combination with one or more similar reactors at a single site.
25	B. At any time prior to the filing of an application for a certificate to construct a small modular
26	nuclear facility to serve customers in the Commonwealth or in West Virginia, a Phase I Utility may request

27	the Commission to review the Phase I Utility's decision to incur project development costs. The
28	Commission shall hold a hearing regarding the request and shall issue a final order within 180 days after
29	the date on which the Phase I Utility files its request.
30	C. All approved reasonable and prudent project development costs incurred for a potential small
31	modular nuclear facility shall be recovered through a rate adjustment clause filed pursuant to subdivision
32	A 6 of § 56-585.1, amortized over a period equal to the period during which the costs were incurred or
33	five years, whichever is greater.
34	D. If a Phase I Utility serves customers in more than one jurisdiction, the percentage of project
35	development costs to be recovered shall be equal to the percentage of associated energy and capacity from
36	the small modular nuclear facility that is assigned to serve customers located in the Commonwealth.
37	E. As part of a final order approving cost recovery pursuant to this section, the Commission may
38	impose a deadline by which the Phase I Utility shall either (i) place a small modular nuclear facility into
39	commercial operation or (ii) sell the permitted site and return the proceeds of the sale to customers. The
40	length of such deadline shall be at the Commission's discretion; however, it shall provide the utility a
41	reasonable timeframe in which to obtain all necessary permits and approvals, including allowing for
42	approval by federal agencies such as the Nuclear Regulatory Commission, and completing construction
43	of a small modular nuclear facility.
44	2. That the provisions of this act shall expire on July 1, 2034.
