6	A BILL to amend the Code of Virginia by adding in Title 52 a chapter numbered 13, consisting of sections
7	numbered 52-53 and 52-54, relating to enforcement of illegal gaming laws; Illegal Gaming
8	Enforcement Coordinator established.
9	Be it enacted by the General Assembly of Virginia:
10	1. That the Code of Virginia is amended by adding in Title 52 a chapter numbered 13, consisting of
11	sections numbered 52-53 and 52-54, as follows:
12	CHAPTER 13.
13	ILLEGAL GAMING ENFORCEMENT.
14	§ 52-53. Definitions.
15	As used in this chapter, unless the context requires a different meaning:
16	"Coordinator" means the position of the Illegal Gaming Enforcement Coordinator established
17	pursuant to § 52-54.
18	"Department" means the Department of State Police.
19	"Illegal gaming laws" means the laws regulating gambling under Article 1 (§ 18.2-325 et seq.) of
20	Chapter 8 of Title 18.2, charitable gaming under Article 1.1:1 (§ 18.2-340.15 et seq.) of Chapter 8 of Title
21	18.2, lottery games under Article 1 (§ 58.1-4000 et seq.) of Chapter 40 of Title 58.1, sports betting under
22	Article 2 (§ 58.1-4030 et seq.) of Chapter 40 of Title 58.1, casino gaming under Chapter 41 (§ 58.1-4100
23	et seq.) of Title 58.1, fantasy contests under Chapter 51 (§ 59.1-556 et seq.) of Title 59.1, horse racing and
24	pari-mutuel wagering under Chapter 29 (§ 59.1-364 et seq.) of Title 59.1, any regulations promulgated
25	pursuant to such laws, and any other federal, state, or local laws the Illegal Gaming Enforcement
26	Coordinator deems relevant.

27	"Superintendent" means the Superintendent of State Police.
28	§ 52-54. Office of the Illegal Gaming Enforcement Coordinator established; purpose; duties.
29	A. The Superintendent shall designate a Department employee to serve as the Illegal Gaming
30	Enforcement Coordinator. The purpose of the office of the Coordinator shall be to synchronize the
31	enforcement of illegal gaming laws by state and local law enforcement, and to serve as a liaison between
32	such agencies and federal law enforcement.
33	B. The Coordinator shall have the following duties:
34	1. Coordinating enforcement of the Commonwealth's illegal gaming laws by the Department, the
35	Department of Agriculture and Consumer Services, and all other state agencies; attorneys for the
36	Commonwealth; and local law enforcement;
37	2. Acting as a liaison between the federal government and the agencies identified in subdivision 1
38	for purposes of any federal investigation into illegal gaming activities;
39	3. Establishing, advertising, and administering a tip line, which may be accessed by phone and by
40	Internet, for members of the public to report concerns about, or suspected instances of, illegal gaming
41	activities; and
42	4. Performing any other duties as are necessary to promote and enable the equitable enforcement
43	of illegal gaming laws in the Commonwealth.
