10	1. That the Code of Virginia is amended by adding a section numbered 22.1-199.8 as follows:
11	§ 22.1-199.8. Advanced Placement/International Baccalaureate Exam Fee Reduction Fund

13	A. There is hereby created in the state treasury a special nonreverting fund to be known as the
14	Advanced Placement/International Baccalaureate (AP/IB) Exam Fee Reduction Fund, referred to in this
15	section as "the Fund." The Fund shall be established on the books of the Comptroller. All funds
16	appropriated for such purpose and any gifts, donations, grants, bequests, and other funds received on its
17	behalf shall be paid into the state treasury and credited to the Fund. Interest earned on moneys in the Fund
18	shall remain in the Fund and be credited to it. Any moneys remaining in the Fund, including interest
19	thereon, at the end of each fiscal year shall not revert to the general fund but shall remain in the Fund.
20	Moneys in the Fund shall be used solely for the purposes of awarding grants to local school divisions
21	pursuant to the AP/IB Exam Fee Reduction Program as set forth in subsection B. Expenditures and
22	disbursements from the Fund shall be made by the State Treasurer on warrants issued by the Comptroller
23	upon written request signed by the Superintendent.
24	B. There is hereby established the AP/IB Exam Fee Reduction Program (the Program) for the
25	purpose of covering all but \$20 of the last dollar cost of applicable fees associated with taking an AP or
26	IB examination for any public high school student who is eligible to receive free or reduced price lunch
