6	A BILL to amend the Code of Virginia by adding a section numbered 36-139.9, relating to local housing
7	policy; report to Department of Housing and Community Development.
8	Be it enacted by the General Assembly of Virginia:
9	1. That the Code of Virginia is amended by adding a section numbered 36-139.9 as follows:
10	§ 36-139.9. Local housing policy; report to Department.
11	A. Any locality with a population greater than 3,500 shall submit annually to the Department a
11	report summarizing the adoption or amendment of any local policies, ordinances, or processes affecting
12	the development and construction of housing taken during the preceding fiscal year. Such report shall
14	contain a description of the following items and, if available, a reference to where additional information
15	can be found on the locality's website:
16	<u>1. Adoption or amendment of a local proffer policy enacted by the locality pursuant to § 15.2-</u>
17	<u>2298, 15.2-2303, or 15.2-2303.1;</u>
18	2. Adoption or amendment of any provisions of the zoning ordinance affecting the development,
19	redevelopment, or construction of single-family or multifamily housing;
20	3. Adoption or amendment of any provisions of the subdivision ordinance affecting the
21	development, redevelopment, or construction of single-family or multifamily housing;
22	4. Revisions to the comprehensive plan affecting the location, density, or character of single-family
23	or multifamily housing, including the adoption of any zones, areas, or districts designed to encourage
24	residential revitalization, redevelopment, or construction of a targeted geographic area;
25	5. Adoption or amendment of any ordinances, incentives, or policies designed to encourage the
26	development, redevelopment, or construction of housing, including accessory dwelling unit ordinances,

27	affordable dwelling unit ordinances pursuant to § 15.2-2304, 15.2-2305, or 15.2-2305.1, fee waivers,
28	density bonuses, waiver or reduction of local parking requirements, new construction or rehabilitation tax
29	incentives, expedited plan review or permitting programs, and development standard modifications;
30	6. Changes to any local fees associated with the reviewing, permitting, and construction of
31	residential development activities; and
32	7. Any studies or reports conducted and published by the locality related to local housing (i) market
33	conditions, (ii) supply, (iii) trends, or (iv) projections.
34	B. Reports submitted by localities pursuant to this section shall be submitted to the Department
35	annually by September 1 for the preceding fiscal year. Reports shall be submitted in accordance with any
36	forms and requirements developed by the Department, in consultation with the Commission on Local
37	Government. The Department shall make all reports available to the public on its website.
