12	and domestic relations district court judges, the maximum number as hereinafter set forth, who shall		
13	during their service reside within their respective districts, except as provided in § 16.1-69.16, and whose		
14	compensation and powers shall be the same as now and hereafter prescribed for general district court		
15	judges and juvenile and domestic relations district court judges.
